Vision of ESU 10 MTSS:

- All ESU schools/districts (preschool through high school) use a multi-tier approach that addresses behavior, social and academic domains simultaneously.
- Social curricula and behavioral framework are taught with as much rigor and fidelity as academic subjects.
- Meaningful data are collected and used to inform decisions regarding programming.
- Schools/districts closely examine the MTSS infrastructure already in place then determine what needs to be revised or added, based on data.
- All ESU 10 schools/districts incorporate the tenets of AQuESTT as they align the continuous school improvement and ILCD processes within an MTSS framework.
